6.1 Plan for the implementation of the CTU's strategic plan for 2024

The Vice-Rector Prof. Zbyněk Škvor presented the draft Plan for the Implementation of the CTU Strategic Plan in Prague for 2024.
The Scientific Council discussed the Plan of Implementation of the CTU in Prague Strategic Plan for 2024 without any comments.
6.2 DSP - accreditation expiring 31 December 2024 - information was provided by the Vice-Rector. ŠKVOR
The date is set directly by the wording of the Act and cannot be moved except by amendment. At the time of the adoption of this regulation, the legislator assumed that Act 111/1998 Coll. would be amended by the deadline in order to allow for transfer to another related programme accredited for a longer period of time, if necessary. This amendment has now been resubmitted to the Parliament of the Czech Republic. Whether it will be valid and effective in time cannot be said with certainty at this point. There is still a year left to defend dissertations in existing degree programmes. If the study and living conditions allow, the dissertations should be submitted before the end of June 2024, which will allow the study to be concluded within the validity period of the accreditation, fully under the existing conditions. Should it not be possible to submit and defend the dissertation by the end of 2024, the further course of action will depend on the wording and effective date of the approved amendment to the Higher Education Act. The CTU is closely monitoring the development of the situation and will report on it.
6.3 Pror. Škvor - Funding for Student Scientific Research for 2024 has been cut by 10\% from 2023.
6.4 The February 20, 2024 regular meeting of the Scientific Council is cancelled. The next ordinary meeting will be held on 19 March 2024.
